## **RV PARK expansion proposed**

An article recently appeared in the Pelican Press telling of a public hearing on an RV Park proposal to be held at the Scambler Township Hall, February 25, at 7:00 p.m. After collection of public input a decision will ultimately be made by the Township whether or not to grant a conditional use permit for the RV Park. The process calls for a comment period for area residents to provide input to the Township. ### **New Otter Tail County Shoreland Ordinances**

New ordinances proposed by Otter Tail County provide for each lake property owner to stay 10 feet back from imaginary lines going out to the lake. If this becomes law, then each owner will have 20 feet of open space because each owner has to stay back 10 feet from each property line in the lake. If an owner has a 50 foot lot, then only 30 feet of lake space is usable because 10 feet per side is unusable area. An owner can put a 6 foot high fence next to his neighbor, right on the property line but in the lake there is a 10 foot setback. The good thing about the ordinance is to have a guideline of where the imaginary line is in the lake and what happens if a neighbor will not settle the neighborly dispute of being over the line.
