Boat Parade

The annual Boat Parade on Pelican Lake will be held on Tuesday, the 4th of July. The parade starts at 10:00 AM. and the gathering point is off Haugen's Point (the inlet to Fish Lake). Classic wooden boats will lead the parade. Participants are encouraged to decorate their boats (no theme other than Independence Day). You can go all out or just add a flag or two, but all boats are welcome, decorated or not. The parade will travel clockwise around the lake. Join the parade for the entire trip around the lake, join in for as long as you want, or join in as the parade passes your cabin. When joining the parade en route, join as the last parade boat passes your cabin. Travel slowly, not too close to the boat in front of you, get as close to shore as is safe and wave. Please remember this is for fun only! The real reward is the chance to celebrate Independence Day and to enjoy the lakes with family, friends and neighbors. Swimmer's Itch Hits Minnesota's Lake Country Early

DETROIT LAKES, Minn.-Unfortunately, the term "swimmer's itch" does not refer to that nagging desire you get to jump in the lake after a long winter. Instead, according to the Minnesota Department of Natural Resources, it is a temporary skin rash that is caused by an allergic reaction to microscopic parasites carried by waterfowl, semi-aquatic mammals and snails-and it's already hit the waters of Detroit Lakes, with lake-goers reporting symptoms of swimmer's itch less than a week into June.

Muskie Update

The need for change in muskie stocking, (and overall fish management) in Pelican Lake, Otter Tail County and Statewide continues to be obvious. As you know the Otter Tail County wide effort did stop the stocking of new muskie lakes in OTC. The statewide effort by Minnesotans for Family Fishing and Healthy Lakes (MFFHL) continues to work with the state legislature for long range change to the stocking of expensive, predator muskie fish into non-native lakes. With the latest MNDNR data showing muskie in 13th place in popularity, how does anybody explain that muskie are in third place in stocking and management dollars, while only involving less than 2 % of the MN fishing license buyers. And when the MNDNR Commissioner was pushing for license fee increases this past legislative session, walleye stocking dollars were threatened, with no mention of muskie cuts. While surrounding states have increased fishing license sales and tourism, MN fisherman, and people from other states "drive though" Minnesota (the "Walleye State") on their way to spend money in surrounding states who successfully manage for walleye and other sport fish.

The PLPOA Board continues to ask the MNDNR to stop muskie stocking, and contrary to what the local MNDNR office promotes, **PLPOA never officially asked for muskie stocking**. See the history of muskie stocking on Pelican Lake, click **HERE**.

The misrepresentation of the need, costs, and support of muskie fishing continues to be exaggerated and promoted by a few in the MNDNR. And these "public servants", paid for by your tax dollars, continue to violate and abuse their own stated goals, while breaking their own rules and guidelines trying to promote their biased agenda. At a recent PLPOA board meeting it was agreed we should continue to push our request to stop muskie stocking on Pelican Lake. For this reason, we will be circulating an electronic petition on muskie stocking among PLPOA Members and will be asking property owners, fisherman and other OTC residents to sign our written petition to stop muskie stocking on Pelican Lake. The written petition will be circulated around the lake and will also be available at the PLPOA Annual Member Meeting on July 22.

PLPOA Members are encouraged to complete the electronic petition when the link is received in the email.



2017 Pelican Lake Sailing School

Pelican Lake Sailing School Update

- Things are falling into place for this season. As part of the county 9 road agreement, Pelican Lake Sailing School has purchased about \$10,000 worth of 8' wide dock to put next to shore to get students as far from the road as possible. The county has agreed to step up their efforts to slow traffic down during those time periods as well. We also purchased another slightly used Club 420 to replace one of the aging ones that is now for sale and a small outboard to put on another chase boat. The much appreciated PLPOA \$2000 donation along with other donations will go toward paying for this equipment.
- We have 3 youth instructors back and have sent a 4th instructor to US Sailing Small Boat Level One instruction in Minneapolis. This is a great program that considerably lowers the amount of time it takes to get them up to speed.
- Session 1 is full for the Open Bics (typically Kids age 9 12) and there is a little room for Club 420s (typically Kids age 13 through high school.
- Session 2 is nearly full for Open Bics and still room for Club 420s.
- Session 3 has room in both categories.

Minnesota to Accelerate the Pace of Progress Towards Clean Water

That is why Governor Dayton recently announced a new 25 by 25 Water Quality Goal, which would spur collaboration and action to improve Minnesota's water quality 25 percent by 2025. Without additional action, the quality of Minnesota's waters is expected to improve only 6 to 8 percent by 2034. Governor Dayton wants to hear from Minnesotans and will host a series of Town Halls over the summer and fall. In addition, he is calling on Minnesotans and civic organizations to organize their own Community Water Meetings this summer to provide further feedback and ideas.

Gather your community, school, family and friends to have a conversation this

summer about what you can do at the local level to help Minnesota reach our 25 by 25 goal!

Community Water Meetings will take place June - August. Hosts will be provided with a conversation guide, information on water quality in your local

AIS Monitoring

The Pelican Group of Lakes have zebra mussels, but there are many other aquatic invasive species (AIS) that we are working to protect the lake from. July is peak time for the spread of new AIS. PGOLID monitors the lake specifically for spiny waterflea, starry stonewort, flowering rush, Eurasian

milfoil, and we're always on the lookout for any new infestations. Please help us prevent the spread of AIS by informing any guests you may have on the lake this summer to clean, drain, and dry their boat before launching it in Pelican Lake or any other lake. Please inform others of the risks and ensure best practices are followed to prevent further spread and environmental impact of AIS to the waterways.

PGOLID History Project

In the summer of 2019, **PGOLID** will be celebrating their 25th anniversary. We are starting a history project this summer to gather stories the lake so we can put them together for an anniversary celebration.
